BOURSE APPLICATION – TERM & CONDITIONS

Security will be provided starting Thursday, September 9, 2010 8 AM and end 30 minutes after the closing of the show on Saturday. All loading and unloading must be done on the northeast corner of the convention center, using the 12 foot garage door provided for loading and unloading.

Sale or transfer of tables will not be permitted without the consent and approval of the bourse chairman. Sponsor also reserves the right to accept or deny any application, prior to or during the show solely on the sponsors judgment. Tables may not be sublet and once vacated by the dealer will revert to the bourse chairman for his disposition. All bourse dealers must be a member of ILNA and membership fee is \$10 per year.

Send \$100 per table by February 15, 2010 to reserve your same table. We strongly recommend that table applications be submitted during the show to protect your table. Tables will be reserved until February 15, 2010 without a deposit. Applications without a deposit will not be added to the waiting list.

Bourse dealer badges are not transferable and shall not be loaned or given to others. Violation of this provision may result in suspension of bourse privileges.

Bourse dealers agree not to use supplementary tables not supplied as part of standard bourse package to create additional display space immediately adjoining public aisles.

Bourse tables not claimed by 5PM on Thursday may be reassigned with no refund to bourse dealer. Unless prior arrangements are made with Bourse Chairman.

Club, associations or numismatic society tables shall be used for noncommercial purposes only and no items shall either be bought or sold in, at or from such tables.

Early Bird Badges are \$45.00 each.

A fee of \$25.00 is charged for table cancellations made within 30 days of the show date.

The Bourse Chairman will contact dealers when payment is due, approximately three weeks before due date. It is the dealer's responsibility to see that monies are received by the DUE DATE. Cases and lights must be ordered in advance. Additional cases and lights may not be available for rental at the convention site.

If you would like to have a ad in the show brochure that is given to all attendees of the show. Contact Jim Paicz. The ads will run between \$40 and \$50 depending on size.

Reserve your motel room today. The Chicago Speedway is only a few miles from the convention center and there may be a race that weekend. You can always change your reservation later. Traffic from the race will not affect the show, but motel rooms will be hard to find.
